



WHO Code in Plain English: A Course for Lactation Consultants on the WHO's International Code of Marketing of Breastmilk Substitutes

In 1981, the World Health Organization's International Code of Marketing of Breastmilk Substitutes (aka "the Code") was issued. Thereafter, the International Board of Lactation Consultant Examiners required all IBCLCs to comply with the Code and integrated it into the IBCLC Code of Ethics. Hence all IBCLCs should expect to face examination questions related to the Code, and to face disciplinary action if they are not in compliance with the WHO Code.

In 2024, the International Board of Lactation Consultant Examiners made it mandatory for all first-time certificants and all re-certifiers to complete at least 2 hours of training on this Code.

Goal

Within the IBCLC's role, comply with the tenets of the International Code of Marketing of Breastmilk Substitutes at the individual, healthcare facility, and system level.

Objectives

- Describe the aim and scope of the "Code."
- Distinguish between those issues that are and are not included in the scope of the Code, and their related implications.
- Define and recognize examples of at least 10 terms found in the "Code."
- Differentiate between examples of *samples* and *supplies* in terms of purpose, quantity, duration, and cost.
- Recognize examples of how healthcare systems, healthcare workers or manufacturers are compliant/non-compliant with the Code with issues such as:
 - o promotion of breastmilk substitutes
 - o education and information
 - o labeling
 - o words/images
 - o unsuitable products
 - o financial or material inducements
 - o equipment/utensils that are/aren't allowable
 - o disclosure of product affiliations
 - o product displays
 - o posters, distribution of promotional materials,
 - o gifts, hospital practices
- Recognize myths related to the "Code."
